Barry Bluestone (board member emeritus) Northeastern University Since 1999, Bluestone has been the founding director of the Kitty and Michael Dukakis Center for Urban and Regional Policy at Northeastern in Boston, where he was also the founding dean of the University's School of Public Policy and Urban Affairs from 2008 to 2012. He served as a member of the senior policy staff of Congressman Richard Gephardt in 1995 and was a Senior Visiting Fellow at the Boston Federal Reserve Bank in 2013. Industrial Areas Foundation Corti's is the national co-director of the Industrial Areas Foundation (IAF), a nonprofit organization founded in Chicago by the late Saul Alinsky.
