Glanville Llewelyn Williams QC (Hon) FBA (15 February 1911 – 10 April 1997) was a Welsh legal scholar who was the Rouse Ball Professor of English Law at the University of Cambridge from 1968 to 1978 and the Quain Professor of Jurisprudence at University College, London, from 1945 to 1955. Glanville Llewelyn Williams was a British educator and author. He was a noted expert in matters concerning British civil and criminal law. Williams took a major part in the campaign to liberalise the law on abortion, which largely succeeded with the Abortion Act of 1967. He was well-regarded for his books of law, including *The Sanctity of Life and the Criminal Law*, *Criminal Law: The General Part*, *Learning the Law*, *Joint Torts and Contributory Negligence*, and *Liability for Animals*. In the 1950s he was among the first to draw public attention to the problems children face when giving evidence in sex cases and was still campaigning on the subject in the 1980s.
