New Year's Revolution (2005) was the first annual New Year's Revolution pay-per-view (PPV) event produced by World Wrestling Entertainment Raw brand. It took place on January 9, 2005, at the Coliseo de Puerto Rico in San Juan, Puerto Rico. The event was the first (and so far only) pay-per-view event produced by WWE to be held in Puerto Rico. Tickets for this event sold out in less than a month after being available for sale, marking one of the fastest selling events in the short history of the Coliseum.
